PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Monteverde Ranch Equestrian Center, LLC., (MVREC), their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as MVREC), I hereby agree to release, indemnify, and discharge MVREC on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that horseback riding entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to oneself, to property, or to third parties. I understand that such a risk simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: contect with wild animals, hiking and exposure to the elements. A horse, regardless of its training and usual past behavior, may act unpredictably at times based upon instinct of fright which may cause you to be thrown from your horse or injured by the horse. Horses may do such things as bite, kick, buck, lie down, or stumble. Saddles may slip and other tack or saddle problems may develop as a result of normal use and wear. Your horse may collide with obstacles or encounter variations in terrain such as creeks, water, bridges; traveled roads, wild animals, birds, stump, forest growth, debris, rocks and cliffs and other obstacles whether obvious or not and whether man made or natural. Each of those obstacles or variations in terrain could cause you to lose control of your horse and you could fall. Riding a horse requires the participant to balance on the saddle. Participants may lose their balance that can result in falling from the horse. Furthermore, MVREC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's filnessor abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. Our participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless MVREC and any of its officers, agents, employees, or licensees, harmless from any and all claims, demands or causes of action, which are in any way connected with any participation in this activity or my use of MVREC's equipment, horse or facilities, including and such claims which allege negligence acts or omission of MVREC.
- 4. Should MVREC or anyone acting on their behalf, be required to incur attorney fees and costs to enforce this agreement, we agree to indemnify and hold them harmless for all such fees and costs.
- 5. I certify that we have adequate insurance to cover any injury or damage we may cause or suffer while participating, or else we agree to bear the costs of such injury or damage to oneself. We further certify that we are willing to assume the risk of any medical or physical condition we may have.
- 6. In the event that we file a lawsuit against MVREC, I agree to do so solely in the Stale of California, and I further agree that the substentive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this agreement, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against MVREC on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understand it, and I agree to be bound by its terms.
